TERMS AND CONDITIONS:

How to Book:

- a) Please complete this reservation form, sign it and return it together with a non-refundable deposit of 20% of your fare. On receipt of your reservation, subject to availability, your safari will be reserved. Your booking will be confirmed within 48 hours in writing.
- b) Final payment is due not later than 4 weeks prior to date of departure. On receipt of your full payment you will be sent the safari information package, indemnity form, clothing list etc. Please ensure that you receive the information before you leave on your safari.
- c) Bookings made with less than 4 weeks to departure date need to be paid in full at the time of booking.
- d) All travelers will be required to sign our waiver and indemnity form on departure.

Cancellations: Cancellations will only be effective on receipt of written notification. If your cancellation is made after 4 weeks prior to your date of departure your full payment will be forfeited.

Wild animals: Please be aware that while on these safaris you may come into close contact with wild animals. While every effort is made to care for our client's safety, no safari into the African bush and wilderness can guarantee that this will not occur. Attacks by wild animals are however extremely rare. Neither Freelance Tours & Travels Ltd., Tanzania, nor their employees, nor agents can held responsible for any injury or incident on the safari. Please note that you will be travelling in unfenced areas. A certain amount of physical agility is required to participate.

Passports and Visas: The responsibility is upon the client to ensure that passports and visa are valid for Tanzania. The company, their staff and their agents cannot be held liable for any visas, etc. not held by clients, or the cost of visas.

Health: Anti-malaria precautions are recommended even though your trip may be booked during a low risk period. This should be commenced prior to your departure. Please consult your doctor for specific advice.

Included: All park fees, lodges or camping fees (FB), ground transport with 4wheel-drive vehicles with open game viewing roof-tops, mineral water and tour driver guide. For Matema Beach activities such as boat trips and fishing are provided for.

Not included: Insurance to cover for cancellations and curtailment, medical, baggage, money, emergency evacuation back home, beverages except for mineral water, gratuities to staff, any excursion not related to the safari, scheduled airfares and departure fares.

Responsibility: Neither Freelance Tours & Travels Ltd., Tanzania (the company) nor any person or agent acting for, through or on behalf of the Company shall be liable for any loss or damage whatsoever arising from any cause whatsoever and without restriction the generality of the a foregoing shall particularly not be responsible for loss or damage arising from any error or omission contained in this information or other literature, loss or damage caused by delays, sickness, theft, injury or death. In addition the Company shall have the right at any time at its discretion to cancel any safari or the remainder thereof or make any alteration in route, accommodation, price, or other details and, in the event of any safari being rendered impossible, illegal or inadvisable by weather, the extra expense incurred as a result thereof shall be the responsibility of the passenger. The Company may at its discretion and without liability or cost to itself at any time cancel or terminate the clients booking and in particular without limiting the generality of the foregoing it shall be entitled to do so in the event of the illness or the illegal or incompatible behaviour of the client, who shall in such circumstance not be entitled to any refund. The person making any booking will, by the making of such booking, warrant that he or she has authority to enter into a contract on behalf of the other person included in such a booking and in the event of the failure of any or all of the other persons so included to make payment, the person making the booking shall by his/her signature thereof assume personal liability for the total price of all bookings made by him/her.

Photography: The company reserves the right without further notice to make use of any photographs or film taken on the safari by our staff & guides without payment or permission. We do however guarantee that no photographs of a compromising nature will be used.

Change of Schedules: Although every effort is made to adhere to schedules it should be borne in mind that the Company reserves the right and in fact is obligated to occasionally change routes and camping areas as directed by changing conditions. Such conditions may be brought about by seasonal rainfall, on bush tracks and game areas, by dramatic change in water levels, or airline, or other booking problems, etc.

Refunds: Whilst the Company uses its best undertaking to ensure that all anticipated camp sites are available as planned, there shall be no claim of any nature whatsoever against the company for a

Insurance: It is a condition of booking, that the sole responsibility lies with the client to ensure that they carry the correct comprehensive travel and medical insurance to cover themselves, as well as any dependants/travelling companions for the duration of their trip to Tanzania. This insurance should include cover in respect of, but not limited to, the following eventualities: curtailment or cancellation of the safari, emergency evacuation expenses, medical expenses, and repatriation expenses, damage/theft/loss of personal baggage, money or goods. Freelance Tours & Travels Ltd., Tanzania, including their representatives, employees and agents will take no responsibility for any costs, losses incurred or suffered by the client, or the client's dependants or travelling companions, with regards to, but not limited to, any of the above mentioned eventualities. Clients will be charged directly by the relevant service providers for any emergency services they may require, and may find themselves in a position unable to access such services should they not be carrying the relevant insurance cover.

Prices: We will do our utmost to keep to the prices published. Should increases be forced on us by airlines, exchange rates, fuel price increases etc., we reserve the right to a surcharge, up to a maximum of 10% of your tour fare.

Delays: We cannot be held liable for any delays or additional costs as a result of delays.

Consent: The payment of the deposit or any other partial payment for a reservation on a safari constitutes consent by all guests covered by that payment to all provisions of the conditions and general information received by the client whether the client has signed the booking form or not. The terms under which you agree to take these safaris, cannot be changed or amended except in writing signed by an authorised director of the company.

Age limits: The age limit is eight years old, unless through prior arrangement. If anyone is under this age we reserve the right to terminate the safari without compensation.
